I. Subcommittee Updates and Announcements

- a. DHSP Partner Notification Letter – The letter that was submitted to DHSP last month needs to be re-submitted and addressed to Mario Perez. John will notify Grissel to re-submit letter.
- b. Co-chair nominations – There is one open co-chair seat for the C+T subcommittee. Nomination and elections will occur at April meeting. Subcommittee members will begin thinking about potential nominees.
- c. Blood-bank update – Another young person has reported that his HIV status was disclosed in a letter mailed to his home after he tested positive at a blood drive sponsored by Red Cross. Raenisha is in contact with client and his family.
 - Raenisha will get more information from family at next appointment (late April)
 - After getting all the facts and family’s consent, C+T will contact the representative from Red Cross who spoke at C+T meeting last year about disclosure and confidentiality in reporting HIV results to minors.
 - John will contact School subcommittee to see if they are interested in working on this issue, since at least one of these cases happened at a school-based blood drive.
- d. NYHAAD – NYHAAD is April 10 and there are events happening in LA the entire week of the 10th. As a result of the presentation by the NYHAAD Youth Ambassadors at the February C2P Working Group meeting, C2P is having internal discussions about youth involvement and youth engagement within the coalition.
 - There will be a Youth-Adult Partnerships training (date/location TBA) for coalition members coming soon.

II. Minor Consent and Confidentiality Webinar

- a. CFHC/AHWG is not able to meet deadline of March 31 due to scheduling conflicts.
- b. C+T agreed to explore other options and extend deadline in order to accommodate all parties’ schedules and ensure the webinar is of high quality and not rushed.
- c. New action plan for webinar:
 - John will consult with Sarah from AHWG to develop new timeline.

- Staff from SYPP Center can still help with webinar execution and logistics after March 31, but they will not have a ReadyTalk account for us to use.
 - According to Milton, C2P has funds that can help purchase a one-month subscription to ReadyTalk.
